STATE CORONER'S FINDINGS FOLLOWING THE SHANE TUCK INQUEST

The Victorian State Coroner handed down his findings on 11 December 2023 following the Inquest into the death of Shane Tuck. The Coroner's findings included recommendations that are directed to the Department of Jobs, Skills, Industry and Regions and the Board on matters relating to the extension of regulation to capture amateur boxing, placing restrictions on children and adolescents, investing in

research and considering changes to rules and practices in both competition and training settings. The Board welcomed the State Coroner's findings and is carefully considering those recommendations that apply to it so that a formal response can be provided to the State Coroner by 11 March 2024.

EXHIBITION BOUTS POLICY

The Board has recently formalised its policy and approach for supervising exhibition bouts as the legislation prescribes that any exhibition of boxing, or a combat sport that is conducted for profit is considered 'professional' under section 5 of the Professional Boxing and Combat Sports Act 1985 which means that:

- Contestants must be registered and any proposed match-ups must be considered by the Board.
- Requests for exhibition bouts must be presented at the time of submitting the fight card, with the inclusion of the full names and dates of birth for contestants.
- Children and young people under the age of 18 years are excluded from participating in an exhibition bout regulated by the Board.

In addition to these requirements, it is the Board's requirement that proposed exhibition bouts are scheduled at the commencement of a promotion and modified rulesets will be applied for all disciplines, with further details to follow in future editions of Board Rounds.
